To apply this knowledge to patient care, informed consent, communications with patients and families, administrators, ethics and professional committees. To discuss medical and legal ethics of physician autonomy with regards to the choices of physician participation in various kinds of medical practices and the duties of attorneys with respect to the goals of clients that may raise a conflict of interest under Model Rule 1.16.
